 - b. Injuries resulting from the actions or omissions of others, including but not limited to slips, trips and falls of other participants and flying debris;
 - c. Cuts and abrasions resulting from skin contact with damaged items, debris, or any other surface, person, or equipment;
 - d. Injuries resulting from shock, stress or another injury;
 - e. The aggravation or worsening of any existing medical condition;
 - f. Failure or misuse of safety gear, weapons, or any other items or equipment;
 - g. Failure to follow the Smash Room's instructions or failure to ask for information or assistance;
 - h. Any injury that may occur while moving on or about the premises for any reason, including but not limited to slips, trips and falls, and any and all inherent risks of the use of or participation in a ZRU Recycling Ltd, and the services, equipment and facilities used in ZRU Recycling Ltd and related activities at ZRU Recycling Ltd.



- I further acknowledge that the above list is not inclusive of all possible inherent risks associated with the use of Smash Room’s services, equipment, and facilities, and I agree that such list in no way limits the extent or reach of this Assumption of Risk, Release, and Indemnification.
